



## Tournament Rules

1. Entry fee is \$125.00 per Team, consisting of 1-2 people per boat. One payout per seven boats entered (example 70 boats = 10 payouts). Optional \$25.00 Big Fish Pot (1st and 2nd Big Fish Awards- 60/40%).
2. Blast-off number assigned on receipt of \$125.00 Entry Fee & Form. Winners are responsible for all taxes on any money won.
3. A limit of 5 (five) Largemouth Bass may be weighed in per Team. EXEMPTIONS: Minimum 12" fish, with short fish not being weighed and a 1 (one) pound penalty. There is no Maximum size limit with your Tournament Exemption. Weighing in of a dead fish results in a 1 (one) pound penalty. Exemption Rule - Dead fish are not to be culled by a participant and must be a part of the weigh-in.
4. A Coast Guard approved vest must be worn at all times while the boat is being propelled by the combustion engine.
5. Blast-off is at safe-light on Saturday 21 Nov. Boat check will be prior to blast-off. Check-in will be according to Flight Number: Blast-off numbers 1-25 check-in time is 3:00 p.m., Blast-off numbers 26-50 check-in time is 3:15 p.m., Blast-off numbers 51-75 check-in time is 3:30 p.m., Blast-off numbers 76-100 check-in time is 3:45 p.m., Blast-off numbers 100 plus check-in is 4:00 pm. Competitors who are not checked in by their check-in time will be penalized at a rate of 1 (one) pound per minute, up to 15 minutes at which time their catch will be disqualified.
6. Only artificial baits may be used. No snagging or trolling.
7. Sportsmanship - No Team may fish with-in 50 yards of another competitor who is anchored with the trolling motor up. No team may fish with-in 25 yards of another team without the other Team's permission. No hole sitting by a non-competitor or by another competitor, to aid a Team. Use of alcoholic beverages or illegal drugs during this Event will immediately disqualify Team. All Teams are required to abide by state and federal laws. Triton Dealers and the FOMNTT reserve the right to give Polygraph Test.
8. All Teams must carry a minimum of \$300,000 of liability insurance on any boat they might use during this Event.
9. Any protest must be in writing to the Tournament Board within 10 minutes of close of weigh-in. Tournament Board Members are Joe Clements, Johnny Johnson, Frank Hays, and John Higgins. Interpretation of these rules will be left to the Tournament Board. Infractions of any Rule can result in disqualification.
